6. Agenda Items

6.1 Nomination and Election of Officers for FY 14/15 – Chairman, Vice-Chairman, Clerk/Secretary

Motion made by Chief Lohman to close nominations and proceed to elect current officers - Chief Passalaqua, Chairman; Chief Hall, Vice-Chairman; Melba Hibbard, Clerk/Secretary. Seconded by Chief Skiles. Motion passed.

6.2 Approval of the 2014-2015 Stanislaus County Fire Authority Business Plan:

Chief Passalaqua presented the 2014-2015 Business Plan. The recommended major program change is to add a training component. The projected cost to add training for 2014-2015 is \$53,000. In the past, the county fire agencies' portion of the Regional Fire Training Center (RFTC) agreement was paid individually by each signatory agency. With the approval to use Less Than County-Wide dollars to fund the county fire agency portion of the contract, each agency will not need to individually budget for reimbursement. Also, partnering closely with Modesto Junior College (MJC) enhanced distance education capabilities, such as online courses, that will be available to fire districts. It was also suggested to begin work on revisions of the Business Plan in January instead of June each year to allow ample time for suggestions and changes. Chief Passalaqua presented each position currently funded with a 4% increase projected for fiscal year 2014-2015.

Motion made by Chief Bradley to recommend to the County Board of Supervisors that the Less Than County Wide Fire Tax be returned to districts where funds are generated. No second. Motion failed.

Motion made by Chief Breasher to approve the 2014-15 Business Plan and forward it to the County Board of Supervisors. Chief Klevmyr seconded the motion. A roll call vote was taken. Yes -12; Noes -3 Motion passed.

The next regular meeting is scheduled for September 4, 2014.

The Fire Communications Branch of the Stanislaus County Fire Authority is dedicated to assisting member agencies in providing communications assistance, direction, and training of the communications systems within Stanislaus County.

CAD

Over the past several months, we have had several meetings and conference calls discussing upgrading our CAD mobile and server applications. We are continuing to work towards upgrading our system, and an official letter has been sent to the vendor requesting certain deliverables, on-site support, and a timeline for upgrades to be completed.

MDC Support

Over the past couple months, I have assisted several agencies with MDC repairs. We are continuing to work with the CAD vendor, and are prepared to migrate to Windows 7, once we have a deployable version that the vendor supports.

Active911 Application

Over the past several months, I have worked with various Fire Agencies throughout Stanislaus County to setup Active911 for their agencies. If you have not seen this application, please visit www.active911.com for more information. If your agency decides to start using this application, I am happy to assist and create the link from HipLink to Active911 for your agencies.

Radio Programming/MDC Signaling Updates

The countywide radio reprogramming has been completed. As part of the follow up, I have taken notes while programming all of the agencies, and have updated the MDC-1200 (Push to Talk ID) spreadsheet, with the correct resource names/locations. I am continuing to work with several departments that are revising their identifiers as well.

Radio Cache Updates

Recently, all of the radio cache's stored at SR911 have been deployed. They have all been returned and refurbished, and are back in service. Please remember, if you take a cache of radios out, to return them with new batteries. The incidents will provide these for you at the supply unit, as they are a consumable that is used on the incident. Also, please clean the radios upon your return from an incident. A microfiber

towel and a little bit of time, and they can be cleaned right up. If you discover any issues with any radios, please let us know when you turn them back in.

Tac 9 Radio Frequency Update

We have been successful in our re-licensing of the Tac 9 radio frequency. SR911 has been notified of the license and will begin utilizing Tac 9 again.
