January 20, 2011 Meeting Notes Final

#### V. Emergency Volunteer Center Operations Plan

Mike Wilkinson presented an overview of the United Way of Stanislaus County's Emergency Volunteer Center Operations Plan. The plan addresses the processing of Spontaneous Volunteers in the event of a disaster or emergency. This plan follows ICS/SEMS/NIMS as well as the National Response Framework (NFR). Mike discussed who can activate the Emergency Volunteer Center (EVC), as well as the levels of activation. He also discussed the certifications and Qualifications required to work in the EVC. Mike explained that this plan is designed to incorporate and supplement existing volunteer programs.

#### VI. Stanislaus County Emergency Functions

Deb Thrasher, with Stanislaus County OES presented a power point on the Emergency Functions and the development process as part of the Emergency Operations Plans for the County and the nine Cities. She explained that the functions correlate to similar functions at the Federal and State level and bring together departments and agencies as well as other stakeholders whose daily operations are crucial to the ability of the County and/pr Cities to mitigate, prepare, respond and recover from any emergency. She requested that the Disaster Council approve as to form the Stanislaus County Emergency Functions. The next step will be to send the completed Stanislaus County Emergency Operations Plan to the Board of Supervisors for their approval. Once approved, the templates for the Emergency Functions that will be provided by the cities will be made available to them as well as any assistance needed to complete them.

### VII. <u>Disaster Service Worker Presentation</u>

Chief Gary Hinshaw presented an overview of Disaster Service Workers and discussed the differences between spontaneous and affiliated volunteers. Organizations such as the United Way, Ares, CERT, Medical Reserve Corp, and all government employees are considered Disaster Service Workers and affiliated volunteers. To become an affiliated volunteer, you must take an oath and only authorized individuals, such as the County or City Clerk, or persons they authorize, can swear in Disaster Service Workers. In the event of an emergency or disaster, volunteers must be sworn in as Disaster Service Workers to be eligible for Workers Compensation, should they be injured while volunteering.

The County is currently working on comprehensive Affiliated Volunteers/Disaster Service Worker plan that will address the procedural issues of managing affiliated volunteers which will include registering with an accredited Disaster Council, as well as providing a record keeping system. This plan will also provide a template that the cities can use.

#### VIII. **Medical Reserve Corp Training Plan**

Renee Cartier presented an overview of the Medical Reserve Corp Training Plan which focuses on recruiting and training medical volunteers for the purpose of strengthening the Public Health infrastructure, improving emergency preparedness and fostering community resiliency. She discussed the training tracks for the volunteers that will ensure effective integration of volunteers into the County's emergency response system and will also provide staffing augmentation and support in the event of a potential Medical/Health emergency.

To date there are 220 Disaster Health Care Volunteers registered in Stanislaus County. Of the 220, 106 have received training and are considered deployable. Part of their training includes ICS Training and background tracks.

Renee distributed a table of courses and their descriptions that are being offered to ensure that Stanislaus County Medical Reserve volunteers are trained and approved to participate in the All Point of Dispensing (POD) training exercises that will take place during the annual seasonal flu clinics and the State of California Golden Guardian exercise in May 2011.

Chief Gary Hinshaw reported that at the MARAC meeting that the Department of Water Resources reported a concern that the snow pack was at 247% of normal and could impact the San Joaquin River and the cities of Patterson and Newman if we receive a warm rain, or a long warm spring.

In Stanislaus County, if we receive no more snow or rain, we will be at 75% of normal, and just south of us will be at 105%.

Chairman Rick Robinson discussed the issue of quorums. It has been difficult to ensure that we have a quorum and would encourage cities who have not done so, to consider appointing an alternate. We will also offer Disaster Council Training for the primary and alternate members of the Disaster Council one hour prior to the next meeting.
