- 7.2 Office of Emergency Services Reports OES Staff
 - OES Staffing Updates
 - Ruben Wegner has replaced Shannon Williams as the new OES Manager. An offer has been made to staff Ruben’s old position and the candidate is currently in process of background check before hire.
 - EMS Incorporation Update
 - The County Board of Supervisors approved the establishment of a single-county EMS Agency and terminate the contract with Mountain Valley EMS Agency as of June 30, 2022.
 - Dispatch will continue out of Salida.
 - Richard Murdock will take place as interim Director until a permanent Director is hired in June.

- Stanislaus County Emergency Plan Updates
 - Hazard Mitigation Plan Update
 - Update required every 5 years and OES has hired a contractor to coordinate the 2022 updates. The final plan must be approved by end of June for FEMA compliance.
 - Extreme Cold/Freeze Plan Update
 - Cold/Freeze plan updated to include current warming centers and to maintain consistency with new NWS terminology.
 - Flood Planning Update
 - Final plan and related mapping products completed and to be disseminated to the Reclamation Districts.
- Fire Season Update
 - Predictive services analysis shows normal significant fire activity (1 “large-scale” fire per month) in NorCal region. This season produced 135-140% of snowpack but warmer temps have melted much of this off. Beginning March – May we will continue to experience drying with an increase of fire activity.
- County Security / Fusion Center Updates
 - Ron Reid has stepped down from role as County Security Manager and is now interim Director of Animal Services until a permanent Director can be hired.
 - Ralph Ghimenti is the current County Security Manager. A lieutenant from SO will be placed at OES to support Security and Fusion Center operations.

- Legislative and Regulatory Updates

- 7.3 Sheriff's Department Update Sheriff Dirkse
- The Sheriff will be presenting a variety of COVID related items to the County Board of Supervisors, including lifting the currently declared State of Emergency (SOE). This SOE is separate from the Public Health Officer's medical health SOE.
 - A SWAT Active Shooter exercise was conducted overnight on January 25th at Galaxy Theaters. OES was involved to support operations and to begin integration of emergency management planning concepts with SO operations.
 - SO operations staffing is at 100% for the first time since 2010.
- 7.4 Public Health Update Dr. Vaishampayan
- Dr. Thea Papasozomenos submitted a report on behalf of Dr. Vaishampayan.
 - 2021-22 flu season has been predominated by H3N2 subtype, which tends to be more severe, especially for at-risk groups. Last N3H2 was 2017 and that was a severe season. Overall flu activity in CA has been minimal and CDPH describes as sporadic infection rates. Overall though it's a very low activity flu season.
 - Current COVID variant omicron is majority of current cases. Fully vaxed in County at 57%, partially vaxed (1 or more dose) at 11%. In San Joaquin Valley region, about 43% of those eligible have received their booster. Hospitalizations have been trending downward overall. In the SJV region we are still at a plateau level for hospitalization rates but expect this to be dropping soon.
- 7.5 Cal OES Update Patti Tran
- Continuing to coordinate COVID activities statewide, monitoring drought impact, and still working on fire recovery from last year.
 - Cal-OES Region IV ESC Elsy Votino is retiring and a replacement will be hired soon.


